Business Visa Requirement:

- Valid passport must not be older than 10 years also it must be valid for at least THREE MONTHS longer than the intended stay. The passport must also have at least TWO BLANK PAGES to affix the visa and should be along with all old passport booklets.
- **Coloured photocopy of all the pages of current passport booklet along with the BIO PAGE and VALID VISA PAGES of all old passports booklets (Rs 700/- EXTRA SHALL BE CHARGED for doing this job).**
- 1 Form duly filled and signed at two places(**column #37 and in last**)by applicant.
- 2 Latest Photos (3.5 cm x 4.5 cm with white background with 70 to 80 % face cover area).
- Covering Letter.
- Invitation.
- Hotel Confirmation.
- Return Confirmed Ticket (Tkt itinerary is not acceptable) showing departure after 10 working days.
- Overseas Medical Insurance.
- Latest Personal Bank Statement (6 months).
- IT papers (3 years).
- Mobile number of applicant.
- Authority Letter authorising **Mr Mohan Kumar** of **M/s Jetsave India Tours Pvt Ltd** to submit and collect documents.

PLS NOTE IF PAX NOT TRAVELLED TO SCHENGEN SINCE LAST 3 YEARS AND PAX HOLDING BLANK PPTS THEN EDUCATION DEGREE REQUIRED

The photograph should be a passport size colour photograph.

Has light background.

Is taken from shoulder and above, well lit so that details can be seen.

Is taken straight on.

Is 3.5 X 4.5 cm.

The photograph should be a recent one not more than 6 months old.

Is taken without headgear.

Can be taken with headgear, after consideration on case to case basis if the applicant wears headgear on religious grounds. The main characteristics of the face must be apparent from the photograph. Chin, nose, eyes and eyebrows must not be covered, the forehead should be uncovered to the extent that the shape of the face is apparent.

Is without hat/cap.

Is with the applicants hair tucked behind his/her ears.

The photograph should not have any staple marks.

The photograph should be of good quality, scanned colour photocopies would not be accepted.

Is without sunglasses.

NOTE:

1. Family details of the applicant must be provided with the Date of Birth and occupation(Designation Job joining date) of the family members. In case of student the name of the Institute, course name and joining date is MUST

2. All Tamil Nadu issued passport to appear for interview in Chennai and then carry out interview letter which is to be sent to Delhi along with the documents for final application in Delhi.
3. Prior appointments are must to apply Visa. Appointment timings between 3 to 4 p.m. on any working day. (Monday to Friday)
4. Visa Submission days - Monday to friday .
